*** COMPLAINT PROCEDURES**

Complaints of any kind resulting from the members of BCA who are listed in the BCA Breeders' Directory shall be sent to the Secretary of the Division wherein the BCA member resides for investigation. Upon receipt of the written complaint against the breeder, the Division will appoint a committee of three (3) members (one board) to look into the matter and that the member in question will be provided a copy of the written complaint by the Secretary.

The investigation will take no longer than 90 days from the time the member is notified and that any action will be decided on by the Division Board.

If the committee feels that the complaint(s) are valid, they may recommend any action from a written warning to permanent removal from the Breeder's Directory.
